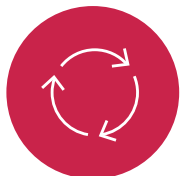

Started to think about relocating? Awesome! Here are some topics for you to consider to help you make your decision.



Travel costs between origin and destination locations

Whether it is an orientation trip to investigate accommodation options, trips back and forth before the move, or your final move trip, travel expenses may include:

- Airfare, car rentals, train tickets between origin and destination.
- Hotel stay or temporary housing and meals for you and your family.
- Pet boarding or shipping costs to get furry companions from A to B.



Moving costs

The packing and transportation of household goods from origin to destination can be a large expense.

- Professional van lines may offer services that provide additional support including packing, placing, disassembling, crating, unpacking or reassembling large furniture or specialty items.
- Moving labor or vehicle rentals (e.g. U-Haul) or other options such as Pods may also be a consideration.



Home sale, home purchase, or lease costs

Whether you are a homeowner or renter, you will incur costs to sell your home or terminate your lease at origin and find a new residence at destination. These may include:

- Home sale preparation costs and closing costs/commissions
- Inspections and closing costs on the purchase of a new home
- Lease cancellation fees to terminate an existing lease early
- Deposit (i.e. first month, last month, security) on a new property



Significant other / family adjustments

In the new location, it will be important to familiarize yourself with the area. How well does it fit your lifestyle and needs? Acquaint yourself with neighborhoods, review schools, potential job opportunities for your spouse. Obtain a new license and registration, choose a bank, locate medical services, or any other family needs.



Significant other / family considerations

If you get contacted by the recruiter be sure to discuss whether the position is relocation eligible as all positions are not eligible for relocation.
